

SUBHARTI MEDICAL COLLEGE, U.P.
FEE STRUCTURE AND OTHER IMPORTANT TERMS AND
CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2017-18 IN
M.B.B.S. COURSE

Important Notes:

1. As per the judgment of the Hon'ble Supreme Court, the State Government was authorized to make an interim fee fixation committee to fix the fee till any Act is made. The State Government has enacted Swami Vivekanand Subharti University Act in 2008 in which the right to fix fee has been given to the University. Thus, **the Swami Vivekanand Subharti University does not come under the purview of the Fee Fixation Committee of the Government for fixation of fee.** However, the committee has the right to oversee whether any profiteering or commercialization of education is not done.
2. **The State Government has issued notification no. 2467/71-2-17-37/2015 dated 14-07-2017 through which it has fixed the fee of MBBS course as Rs. 8.50 lacs per year unilaterally, without even analyzing the Balance Sheet of the College. The said notification is full of arbitrary and false statements and is liable to be quashed.** The College and the University shall be filing Petition at the Hon'ble High Court/appropriate legal forum soon.
3. **The College has proposed Rs. 21 lacs and 45 thousand per year (With 150 annual admissions and 32 lacs per year if the annual intake is reduced to 100).**
4. Since, the college does not want to come in confrontation with the Government at this stage, the College has accepted the fee structure fixed by the State Government under protest. **However, the decision given by the Hon'ble Court/appropriate legal forum shall be applicable on the College as well as on the students. The students will be required to give a registered undertaking-affidavit to this effect. The registration is to be done at the office of the sub-registrar after paying the stamp duty as per the government rule.**
5. In case the College does not get justice by the Government/Hon'ble Court/appropriate legal forum, it may decide to close down. Under such conditions, the students will be shifted to other colleges as per law.
6. Known persons, Faculty members, Government Officers, Ministers etc should not expect any relaxation in the conditions and thus better don't approach the management for any student.
7. **All the students aspiring to take admission in MBBS course at Subharti Medical College, Meerut are advised to go through the following regulations very carefully-**
 - A. Full Fee will be deposited at the time of admission and before the LAST DATE declared by the Counseling Board. No Part payment of Fee is permitted.
 - B. If any amount has been deposited by the candidate with the DGME, U.P. in the head of College fee, it shall be the duty of the candidate to get the certificate

from the DGME that such an amount shall be transferred to the account of the College; otherwise the amount will have to be paid by the student to the college directly.

- C. The candidate will have to submit a Bank Guarantee from a Nationalized Bank of the fee of remaining three and a half years for MBBS course before the LAST DATE of admission as declared by the counseling board. This is in accordance with the judgment of the Hon'ble Supreme Court. However, **this condition can be relaxed in deserving cases on being applied to the Hon'ble V.C. of the University through the Principal Subharti Medical College, Meerut.**
- D. Refundable security deposit will be Rs. 15,00,000/- (Fifteen Lacs).
- E. There will be Enrollment and miscellaneous charges of Rs. 1,70,000/- each year in addition to the Course fee which are related to the medical examination, medical facility fee, sports fee, cultural fee, National Defense fund contribution, examination fee etc which are liable to be paid to the University.
- F. An additional tuition fee and supplementary exam's fee from failed/detained students will be charged.
- G. Hostel is compulsory for all the students except for those whose parents reside in Meerut or Modinagar.
- H. Hostel & Mess charges will be as follows:
 - (a) Rs. 1,50,000/- (Triple/Double Seater-Non AC) per year for Girls. Window AC- optional- if available with additional charges.
 - (b) Rs. 2,00,000/- (Single Seater – Non AC) per year for Girls. Window AC- optional- if available with additional charges.
 - (c) Rs. 2,50,000/- (Double/Triple Seater- Central AC) per year for Boys.
 - (d) Rs. 3,00,000/- (Single Seater- Central AC) per year for Boys.
 - (e) *Different option also available Second year onwards.
- I. Refundable Hostel Security – Rs. 5,00,000/-.
- J. Hostel fee is subject to change any time.
- K. Fee once deposited is non-refundable.
