

UNDERTAKING AFFIDAVIT (for Parents/Guardian)

(Non-Judicial Stamp Paper of Rs.100/-)

Meerut, do hereby solemnly affirm, undertake, and declare as under:

1. That the above mentioned name and address is true and correct.
2. That my ward's date of birth is/...../..... (DD/MM/YY).
3. That my ward has taken admission/been provisionally admitted to the course of MBBS at Subharti Medical College, Meerut for the academic session 2017-18 after knowing the eligibility/requirement of the course. He belongs to Gen/SC/ST/OBC/Physically Handicapped / category.
4. That the documents and other information submitted by my ward to the College are true to best of my knowledge and belief. I understand that if any document or information is found false, admission of my ward may be cancelled without any refund of the fee deposited by me. I shall also be liable to pay the full course fee if any falsehood is found after the last date of admission for this particular year.
5. That my ward is neither pursuing nor will pursue any course at any other College while enrolled/being under the process of enrolment at Swami Vivekanand Subharti University. In case, my ward is found to be pursuing any other course at any other College/Institute, admission of my ward may be cancelled. The fee already deposited shall be forfeited as per the policy of Swami Vivekanand Subharti University and I may be liable to submit the full course fee.
6. That I shall pay the fee of the entire course if my ward withdraws his/her admission after the last date of admission till before completion of the course. This also includes my ward's transfer to any other college before completion of my ward's course.
7. That I have obtained and read prospectus containing rules and regulations of the University/College/ Institute and have read them thoroughly. I undertake that my ward will abide by them in letter and spirit. I understand that failure of my ward to abide by any of them and other instructions issued from time to time by the Institute/College/ University/any other Competent Authority, shall make my ward liable to disciplinary action which may also include suspension/rustication by the University authorities. I understand that the decision taken by the administration in this regard shall be binding and final for my ward and me.
8. That I undertake to pay the fee in time. The last date for payment of fee is 31st July every year effective from the second year of studies. No yearly notice shall be issued and I will be depositing the fee automatically by the 31st July unless declared differently by the Principal/Dean of the College/Institute/Faculty. In case of late payment, I shall be liable to pay fine and penalty as per college rules.

9. That I have been told that there is a Student Grievance Redressal System and in case of any grievance, my ward will follow the rules to get relief by complaining to the relevant authority of the University. In no case my ward or I will take law in our hands, call outsiders to intervene in any dispute and will not file any FIR at any Police Station. In case my ward or I do any such thing/act, my ward will be liable for disciplinary action which may include suspension/rustication from the college.
10. That I ensure that during the whole course, my ward will not participate in any strike or agitation. I understand that having found participating in such activities, my ward will be liable for disciplinary action which may include suspension/rustication from the college.
11. That my ward will maintain good behavior. My ward shall not cause nor does any act to damage the property of the college. If my ward does any act to cause damage to the college property, my ward shall be liable to be punished by the management which may include suspension/rustication of my ward from the college in addition to compensating financially for the damage caused.
12. That I understand that failure to obtain minimum marks as prescribed in internal examination and/or having less than required percent of attendance in practical/classes as prescribed for my ward's course of study, my ward shall render him ineligible to appear in the University examination.
13. That I will not try to pressurize the authorities of the University for allowing my ward to appear in the University Examination if my ward is detained; for passing my ward in the examination etc from any Political Leader, Government Officer, Antisocial element etc. In case I do so my ward will be liable for punishment as decided by the competent authority of the University.
