

UNDERTAKING AFFIDAVIT (for parents/guardians)

(Non-Judicial Stamp Paper of Rs.100/-)

presently at Meerut, do hereby solemnly affirm, undertake, and declare as under:

1. That I have been told about the following policy regarding the College fee and Hostel fee and related issues very clearly which are mentioned herein below and I agree to abide with them totally.
 - (a) That Tuition fee as decided by the State Government is Rs. 8,50,000/- (Rupees Eight lacs and fifty Thousand only) per year. Whereas; the fee decided by the University/College is Rs. 21,45,000/- (Twenty one lacs and forty five thousands only). The matter is under litigation with the Government.
 - (b) That presently I am supposed to pay a sum of Rs. 8,50,000/- (Rupees Eight lacs and fifty Thousand only) per year, however I promise to abide by the decision of the Hon'ble High Court/appropriate legal forum, whenever declared.
 - (c) I am required to deposit the fee every year latest by 31st of July without waiting for any notice or examinations held or result declared or not.
 - (d) That the Registration Fee, University Enrolment Fee, Uniform fee, University Examination Fee, University Sports and Cultural Fee, Medical Examination, facility, Insurance Fee, National Defense fund etc is Rs. 1,70,000/- per year.
 - (e) That Refundable security deposit will be Rs. 15,00,000/- (Fifteen Lacs Only).
 - (f) That I will be required to submit a Bank Guarantee of Rs. 35,70,000/- (Thirty Five lacs Seventy Thousands) for tuition and other annual fee for the remaining period of Course. I have been told that it is in accordance with the judgment passed by the Hon'ble Supreme Court in Islamic Academy of Education Vs State of Karnataka 2003 (6) SCC 722.
 - (g) That a sum of Rs. 50,000/- will be charged per semester per subject for all failed students in each phase of study during the academic year.
 - (h) That additional supplementary examination fee will be payable if my ward fails or is detained in the Regular examination, as per rule of the University.
 - (i) That Hostel is compulsory. Hostel charges are inclusive of mess charges. These are follows-
 - (i) Rs. 1,50,000/- (Triple/Double seater – Non AC) Per year for Girls. Window AC – optional- if available with additional charges.
 - (ii) Rs. 2,00,000/- (Single seater – Non AC) Per year for Girls. Window AC – optional- if available with additional charges.
 - (iii) Rs. 2,50,000/- (Tripple/Double seater – Central AC) Per year for Boys.
 - (iv) Rs. 3,00,000/- (Single seater – Central AC) Per year for Boys.

(v) That Refundable Hostel Security – Rs. 5,00,000/- (Five Lacs)

(vi) The Hostel fee can be changed any time.

2. That my ward shall undergo the course of MBBS in Subharti Medical College for the prescribed period.
3. That my ward shall serve as an Intern in the associated hospital of the College for the prescribed period as per the norms laid down by the College authorities. My ward has been told that internship is part of MBBS course and not a job, therefore no salary/stipend can be claimed by me or my ward for doing internship. However if management gives my ward stipend at any rate, my ward will accept the same and shall not demand equity with any other private or government colleges.
4. That my ward will not demand N.O.C. for doing internship from outside. The College has the right to impose penalty upon my ward if my ward demands N.O.C.
