FEE STRUCTURE AND OTHER IMPORTANT TERMS AND CONDITIONS FOR ADMISSION IN ACADEMIC SESSION 2023-24

M.B.B.S. COURSE

All the students aspiring to take admission in MBBS course at Subharti Medical College, Meerut are advised to go through the following regulations very carefully

1. **That SUBHARTI MEDICAL COLLEGE, MEERUT is Buddhist Minority Institution** recognized by National Commission for Minority Educational Institutions, New Delhi. It was declared a Baudh Minority College by National Commission for Minority Educational Institutions, New Delhi vide letters/orders no. F. No. 1222 of 2015 dated 26.04.2018, no. 7-7/2016-NCMEI/4542 dated 13.08.2018.
2. It is also notified that Subharti Medical College filed a Special Leave Petition no 17003 of 2022 at the Hon'ble Supreme Court of India praying to direct the State Government to treat Subharti Medical College as a minority institution.
3. The Hon'ble Supreme Court has passed an interim order on 20.10.2022, directing the State Government and the DGME to allot Buddhist students on 50% of seats. The relevant portion is quoted herein below:

“Undisputedly, the petitioner No.2/College has been given minority status by the order of the National Commission for Minority Education Institutions, which is the competent authority for the said purposes. It cannot be heard that the petitioner(s) would have a minority status insofar as the institutions coming under Higher and Technical Education Department of the State and will not have a minority status insofar as the institution coming under the Medical Education Department of the State.”
4. DGME, UP vide its letter no. ME-/3/2023/1443 dated 01.07.2023 has notified 100 seats of minority students of Subharti Medical College.
5. The College has proposed fee structure of Subharti Medical College, Meerut (being Minority Institutions) for academic session 2023-24 as follows:-
 - A. General Students:
 - (i) Tuition Fee – Rs. 16,00,000/- per year
 - (ii) Security – Rs. 4,00,000/- (Refundable)
 - (iii) Misc. Charges – Rs. 1,25,000/- per year

B. Students of Buddhist Community:

- (i) Considering that the majority of the Buddhist community belongs to financially compromised section, the College will provide the concession to them in the College fee considering their economic status on being applied.
- (ii) No Buddhist student will be denied admission due to lack of money.

OR

- (a) The tuition fee, hostel & Miscellaneous charges applicable in 2022 academic batch.
 - (b) If the Hon'ble Supreme Court passes the final order in favour of Subharti Medical College the modified fee will be applicable from the beginning of the course, whenever decided.
 - (c) The students will have to enter into a registered agreement that they have been apprised about the above mentioned facts in para 5 (a-b) herein above and they agree with that.
6. Hostel is compulsory for all the students except those who are resident of Meerut City.
Hostel Fee –
- (i) Rs. 2,50,000/- Non AC double seater rooms per year.
 - (ii) AC / Air Cooling facility is subject to availability and additional charge.
7. Besides College Fee, Hostel Fee & refundable Security, the students will have to pay an additional tuition fee @ 1/3 rd of Annual Tuition fee if detained (for whatsoever reason)/failed in each year/session.
8. An additional supplementary exam's fee from failed/detained students will be charged @ Rs. 50,000/- per subject per examination.
9. The students will be required to give an affidavit that in case they leave the course in between they will be required to deposit the full course fee of total duration of the course.
10. It will be compulsory for the students to do internship from the College itself. No request for giving NOC for doing internship from any other Hospital for whatsoever reason shall be entertained.
