Sir/Madam,

With reference to your letter No.SMC/GEN/M-60/5592 dated 11.02.2020 on the subject noted above, I am directed to invite your kind attention to Gazette Notification No. MCI-34(41)/2010-Med./3491, dated 16th April, 2010 ("Establishment of Medical College Regulations, (Amendment), 2010 (Part II)". The operative part of the notification reads as under:-

".....

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

I am further to inform you that the assessment for Continuance of recognition of MBBS degree (150 seats) granted by Swami Vivekanand Subharti University, Meerut in respect of students being trained at Subharti Medical College, Meerut is due on or after 24.01.2025.
