AGREEMENT

This Agreement is made between Subharti Medical College, Meerut, through its Assistant Legal Officer Mr. Sanjay Kumar S/o Shri Gyan Singh R/o Subhartipuram, N.H. 58, Delhi Haridwar Bypass Road, Meerut, U.P. which is called as Party No.1 or the First Party hereinafter,

AND

Agreement shall be as follows:-		

- 1. That the Party No.2 has been allotted a seat in the course of(MD/MS/Diploma) for admission in the department of, at the Subharti Medical College, Meerut, a constituent College of Swami Vivekanand Subharti University, Meerut) through central counseling conducted by the State Government of UP.
- 2. That the Party No. 2 & 3 have been given the 'Document A' by the party no. 1, which contains the fee structure as decided by Government of Uttar Pradesh vide order no. 238/71-4-18-37/2015 dated 31-03-2018 and mentioned in Point no. 1 A (i).
- 3. That the 'Document A' also contains the Fee Structure fixed by Swami Vivekanand Subharti University, the affiliating University of the party no. 1 in Point no. 1. B (i). A copy of the 'Document A' is enclosed with this agreement.
- 4. That the Party No. 2 & 3 have carefully read the **Document A** and understood that the fee structure fixed by State Government is under challenge before the Competent Legal Forum / Hon'ble Court.
- 5. That the fee finally decided by the Competent Legal Forum/ Hon'ble Court shall be acceptable to the Party No. 2 & 3.
- 6. That the Party No. 2 & 3 promise to pay the difference amount of the fee if any, from the beginning of the course within the stipulated time as decided by the University.
- 7. That the Party No. 2 & 3 have thoroughly read and understood the condition no. 2(iii) of the **'Document A'**.
- 8. That the Party No. 2 & 3 understand the duty and commitment of the party no. 2 towards the patients' care. The Party No. 2 & 3 undertake that the party no. 2 will not engage him in any activity, which is detrimental to the interest of the patients of

the hospital of party no. 1 and will do all efforts to maintain the occupancy of the ward allocated to him/her more than 80%, which is as per MCI norms.

- 9. That the Party No. 2 & 3 assure that the party no. 2 will not refer any patient to any other hospital or nursing home without the written permission of the consultant. The Party No. 2 & 3 agree that in case, the party no. 2 is found referring any patient to any other hospital or nursing home without the written permission of the consultant or the competent authority appointed by the party no. 1 or if he/she is found involved in any activity which may result in lowering the bed occupancy of his/her ward below 80%, the party no. 2 shall be liable for punishment as mentioned in clause 2 (iii) of the 'Document A'.
- 10. That the Party No. 2 & 3 understand the duty and commitment of the party no. 2 towards the public living in rural and sub-urban areas. The Party No. 2 & 3 agree that the Party No. 2 will be bound to join the party no. 1, after passing the course, on the appropriate post offered to him by the party no. 1 to serve the masses living in rural, urban and sub-urban areas and work there for a period of two years.
- 11. That the Party No. 2 & 3 have been told that the Party No. 2 will be paid salary of that post on which the Party No. 2 is appointed after passing the course, as per the norms of the party no. 1.
- 12. That the Party no. 2 & 3 shall be bound to this effect that the Party no. 2 will do the job as mentioned in clause no. 10 herein above. The Party no. 2 & 3 undertake that in case the Party no. 2 does not fulfil the condition mentioned in clause no. 10 the Party no. 2 & 3 will be liable to pay a sum of Rs. 50,00,000/-- (Rs. Fifty lacs only) to the party no. 1 as compensation.
